WITH COMMISSIONER MARK JONES BEING ABSENT AND THE FOLLOWING PROCEEDINGS WERE HAD, THAT IS:

Chaplain Javier Maldonado of Christus Hospice Central Texas gave the invocation. Judge Becerra led the court in the Pledge of Allegiance to the United States and Texas flags. Judge Becerra called the meeting to order.

PUBLIC COMMENTS

Dan Lyon made public comment. Rodrigo Amaya made public comment. Michael Lee made public comments regarding the criminal justice system and his support of local law enforcement. Linda Calvert made public comment.

36409 ADOPT A PROCLAMATION DECLARING MAY 2021 AS ELDER ABUSE MONTH.

Sam Cortina, Community Engagement Office with the Department of Family Protection Services, spoke to the court regarding elderly abuse and the services that are offered to families. The Commissioners thanked him for his work and taking time to speak. A motion was made by Commissioner Ingalsbe, seconded by Commissioner Shell to adopt a Proclamation declaring May 2021 as Elder Abuse Month. All present voted "Aye." MOTION PASSED.

36410 ADOPT A PROCLAMATION DECLARING MAY 23-29, 2021 AS SEARCH AND RESCUE WEEK IN HAYS COUNTY.

Justin McInnis, President and CEO of Texas Search and Rescue, stated search and rescue is a big deal in Texas. He called on Jonathan McComb to speak to the court. Jonathan McComb stated that he got involved with search and rescue after he lost his family to the Memorial Day Flood in 2015. He thanked the Commissioners for supporting and acknowledging the search and rescue groups as they are an extension of law enforcement helping people in need. The Commissioners thanked the group for there work. They noted the search and rescue teams are called out often. A motion was made by Commissioner Shell, seconded by Commissioner Ingalsbe to adopt a Proclamation declaring May 23-29, 2021 as Search and Rescue Week in Hays County. All present voted "Aye." MOTION PASSED.

UPDATE FROM THE COUNTY JUDGE AND STAFF REGARDING THE LOCAL DISASTER DECLARATION AND COVID-19. POSSIBLE DISCUSSION AND ACTION MAY FOLLOW.

Mike Jones, Director of Emergency Services, announced that vaccinations are available. He stated that anyone that wants to get a vaccine will be able to receive one. He gave the phone number to contact of 833-521-2766 to arrange a homebound vaccine appointment. Judge Becerra gave an update of the Dunbar Heritage clinic. He mentioned there are new CDC guidelines regarding masks. No action was taken.

36414 APPROVE THE PAYMENT OF THE MAY 31, 2021 **PAYROLL** DISBURSEMENTS IN AN AMOUNT NOT TO EXCEED \$3,975,000.00 EFFECTIVE MAY 2021 28, AND POST **TOTALS** FOR WAGES, WITHHOLDINGS, DEDUCTIONS AND BENEFITS ON THE HAYS COUNTY WEBSITE ONCE FINALIZED.

A motion was made by Commissioner Ingalsbe, seconded by Commissioner Shell to approve the payment of the May 31, 2021 payroll disbursements in an amount not to exceed \$3,975,000.00 effective May 28, 2021 and post totals for wages, withholdings, deductions and benefits on the Hays County website once finalized. All present voted "Aye." MOTION PASSED.

36415 AUTHORIZE ON-SITE SEWAGE FACILITY PERMIT FOR AN EMPLOYEE RESTROOM LOCATED AT 101 WILLOW TERRACE, KYLE TX 78640.

A motion was made by Commissioner Ingalsbe, seconded by Commissioner Jones to authorize On-Site Sewage Facility Permit for an employee restroom located at 101 Willow Terrace, Kyle TX 78640. All present voted "Aye." MOTION PASSED.

AMEND THE TRANSPORTATION DEPARTMENT'S BUDGET FOR ROAD-BUILDING MATERIALS VALUED AT \$30,200.00 TO RECEIVE A SECOND ROUND OF APPROXIMATELY 400 TONS OF LIMESTONE ROCK ASPHALT, TYPE II, GRADE DS MATERIAL FROM THE TEXAS DEPARTMENT OF TRANSPORTATION THROUGH THE 2021 TXDOT SURPLUS PROGRAM AND ADD TO THE DEPARTMENT'S INVENTORY.

Rodrigo Amaya made a public comment against this item. Commissioner Ingalsbe stated this is an amendment to accept a donation of materials from TXDOT. Judge Becerra stated that he agreed with Commissioner Ingalsbe to accept the materials. Marisol Villarreal-Alonzo, Auditor, explained the accounting process for accepting donations. A motion was made by Commissioner Ingalsbe, seconded by Commissioner Jones to amend the Transportation Department's budget for road-building materials valued at \$30,200.00 to receive a second round of approximately 400 tons of Limestone Rock Asphalt, Type II, Grade DS material from the Texas Department of Transportation through the 2021 TxDOT Surplus Program and add to the department's inventory. All present voted "Aye." MOTION PASSED.

AUTHORIZE THE EXECUTION OF A CONTRACT FOR THE TEXAS DEPARTMENT OF STATE HEALTH SERVICES (DSHS), FY22/23 REGIONAL AND LOCAL SERVICES/SYSTEM/LOCAL PUBLIC HEALTH SERVICES (RLSS/LPHS) RENEWAL AWARD, IN THE AMOUNT OF \$102,926.00.

Rodrigo Amaya made a public comment against this item. Vickie Dorsett, Auditor's Office, stated this is a renewal grant. She stated these funds will be accounted for during the budget process. A motion was made by Commissioner Shell, seconded by Commissioner Smith to authorize the execution of a contract for the Texas Department of State Health Services (DSHS), FY22/23 Regional and Local Services/System/Local Public Health Services (RLSS/LPHS) renewal award, in the amount of \$102,926.00. All present voted "Aye." MOTION PASSED.

A motion was made by Commissioner Smith, seconded by Commissioner Shell to accept the Fiscal Year 2020 Hays County Emergency Services District #9 Audit Report per Texas Health and Safety Code 775.082. All present voted "Aye." MOTION PASSED.

A motion was made by Commissioner Ingalsbe, seconded by Commissioner Smith to call for a public hearing on June 1, 2021 to establish a "No Dumping" zone along both sides of Elm Grove Lane between FM 1626 and the cul-de-sac. All present voted "Aye." MOTION PASSED.

RELEASE THE REVEGETATION BOND #107226362 IN THE AMOUNT OF \$2,990.00 FOR 6 CREEKS SUBDIVISION, PHASE 1, SECTION 2.

A motion was made by Commissioner Smith, seconded by Commissioner Shell to release the revegetation bond #107226362 in the amount of \$2,990.00 for 6 Creeks subdivision, Phase 1, Section 2. All present voted "Aye." MOTION PASSED.

36423 GRANT VARIANCES FROM CHAPTERS 721.5.05 AND 721.5.07(C) OF THE HAYS COUNTY DEVELOPMENT REGULATIONS; PLN-1611-NP.

Colby Machacek, County Planner with Development Services, stated this variance is for a proposed 4 lots subdivision in precinct 3. Water services will be provided by Wimberley Water Supply Corporation, and wastewater treatment will be through individual on-site sewage facilities. The owner is requesting a variance regarding shared access driveway A motion was made by Commissioner Shell, seconded by Commissioner Smith to grant variances from Chapters 721.5.05 and 721.5.07(C) of the Hays County Development Regulations. PLN-1611-NP; Oak Terrace Estates (4 lots). All present voted "Aye." MOTION PASSED.

36424 CALL FOR A PUBLIC HEARING ON JUNE 1ST, 2021 TO DISCUSS APPROVAL OF THE PRICE ADDITION, PH 2, LOTS 1 AND 2, REPLAT; PLN-1619-PN.

A motion was made by Commissioner Shell, seconded by Commissioner Smith to call for a Public Hearing on June 1st, 2021 to discuss approval of the Price Addition, Ph 2, Lots 1 and 2, Replat; PLN-1619-PN. All present voted "Aye." MOTION PASSED.

VACATE THE REVISED PLAT OF LOTS 10A & 10B IN THE ROLLING OAKS, SECTION THREE SUBDIVISION; PLN-1694.

Marcus Pacheco, Director of Development Services, the current owners wish to vacate the revised plat to bring the configuration back to when it was platted in 1969.A motion was made by Commissioner Shell, seconded by Commissioner Ingalsbe to vacate the revised plat of lots 10A & 10B in the Rolling Oaks, Section Three Subdivision; PLN-1694. All present voted "Aye." MOTION PASSED.

ESTABLISH ONE TEMPORARY PART-TIME (20 HR PER WEEK) INTERN POSITION FOR THE HAYS COUNTY CHILD PROTECTIVE BOARD EFFECTIVE JUNE 1 THROUGH SEPTEMBER 30, 2021 AND AMEND THE BUDGET ACCORDINGLY.

Karen Brown stated that this position is greatly needed. She explained the requests have increased drastically. Judge Becerra thanked the volunteers for their work. Mark Kennedy, General Counsel, stated that an intern is being requested however, this may be a permanent position in the future. It would be something to look at during the next budget cycle. Commissioner Ingalsbe stated that this was a reasonable request. A motion was made by Commissioner Ingalsbe, seconded by Commissioner Jones to establish one Temporary Parttime (20 hr per week) Intern position for the Hays County Child Protective Board effective June 1 through September 30, 2021 and amend the budget accordingly. All present voted "Aye." MOTION PASSED.

AUTHORIZE BUDGET AMENDMENTS FROM HUMAN RESOURCES CONTRACT SERVICES AND CONTINUING EDUCATION TO TEMPORARY STAFF SALARIES.

Dan Lyon made a public comment regarding a change made to this agenda item. Rodrigo Amaya made a public comment. Commissioner Smith stated this is an extension of a current intern position. Commissioner Shell stated there is a discrepancy from the agenda item and the backup information which maybe causing confusion. After some discussion Commissioner Smith stated he would table this item and bring it back to court. No action was taken.

ACCEPT THE RESIGNATION OF COUNTY COURT AT LAW #3 JUDGE, MILLIE THOMPSON, AND TO DISCUSS IDENTIFICATION AND APPOINTMENT OF A CANDIDATE TO FILL THE VACANCY UNTIL THE NEXT GENERAL ELECTION.

Dan Lyon made a public comment questioning if the letter was in fact written by Millie Thompson. Rodrigo Amaya made a public comment is support of Mike Lee as a candidate for the open County Court Judge position. Laura Ewing made a public comment in support of Linda Rodriguez as a replacement for Millie Thompson. Iris Campbell submitted a public comment through email in support of Linda Rodriguez as a replacement for Millie Thompson. Elaine H. Cardenas, County Clerk, read the comment aloud in court. Mark Kennedy, General Counsel, stated that under the Election Code Chapter 201 the resignation letter would need to be in writing and signed. He also recommended the court make two separate motions, one to accept the resignation, and another for a replacement. Commissioner Ingalsbe stated that she spoke with Linda Rodriguez. She noted that Linda Rodriguez has no intention in running for the position during elections. She stated that she would support Linda Rodriguez as a replacement. Commissioner Jones stated he has talked to Linda Rodriguez and would support her. Commissioner Shell stated he has heard from several people but that he would like to accept resumes. Commissioner Smith stated he would like to have a process for a replacement. Mark Kennedy, General Counsel, stated the court can post the listing with the qualifications listed in Chapter 25 of the Government Code

A motion was made by Commissioner Jones, seconded by Commissioner Ingalsbe to accept the resignation of County Court at Law #3 Judge, Millie Thompson, and to discuss identification and appointment of a candidate to fill the vacancy until the next general election. All present voted "Aye." MOTION PASSED.

A motion was made by Commissioner Ingalsbe, seconded by Judge Becerra to appoint Judge Linda Rodriguez for County Court at Law #3 to replace Millie Thompson. Commissioner Ingalsbe and Judge Becerra voted "Aye." Commissioner Jones, Commissioner Shell, and Commissioner Smith voted "No." MOTION FAILED.

Dan Lyon made a public comment. Commissioner Shell stated he is supportive of having a program manager to keep things moving efficiently. James Jimenez, Halff Associates, spoke to the court and answered the questions from the public regarding the work authorizations. A motion was made by Commissioner Shell, seconded by Commissioner Ingalsbe to authorize the County Judge to execute a Master Services Agreement between Hays County and Halff Associates, Inc., related to program management of the 2020 Parks and Open Space Bond program; and to authorize execution of Work Authorization #1 and Work Authorization #2, associated with said Agreement. All present voted "Aye." MOTION PASSED.

The number of outsourced males was 114 inmates and females were 0 inmates. The number of arrests made by agency are as follows; Buda Police Department - 11, Department of Public Safety - 0, Hays County Sheriff's Department - 56, this includes court ordered commitments, warrant pick-ups from all agencies, and self-surrender warrants from all agencies, Kyle Police Department - 23, San Marcos Police Department - 23, Texas State Police Department - 1. No action was taken.
