### WITH COMMISSIONER MARK JONES BEING ABSENT AND THE FOLLOWING PROCEEDINGS WERE HAD, THAT IS:

Judge Becerra gave the invocation, led the court in the Pledge of Allegiance to the United States and Texas flags, and called the meeting to order.

### **PUBLIC COMMENTS**

Dan Lyon made a public comment regarding property taxes. He stated property taxes are too high and provided a graph to the court comparing Hays County taxes with other county taxes in the state. Lyon also addressed an item from the last meeting expressing concerns about a company's campaign contributions to Commissioner Smith and spoke about logistical issues with jury duty at the Government Center. Rodrigo Amaya made a public comment against drilling lights in the front of the Historical Courthouse and expressed concerns about county employee performance and lost money.

### 37520 ADOPT A PROCLAMATION DECLARING APRIL 25-MAY 2, 2022 AS NATIONAL INFANT IMMUNIZATION WEEK.

Julie Barksdale, Hays County Epidemiologist, spoke about the importance of infant immunization and how vaccines have significantly lowered child mortality rates. She reminded parents to keep their children's vaccines up to date, especially since vaccine rates have lowered during the COVID pandemic. A motion was made by Commissioner Ingalsbe, seconded by Commissioner Shell to adopt a Proclamation declaring April 25-May 2, 2022 as National Infant Immunization Week. All present voted "Aye." MOTION PASSED.

### 37521 ADOPT A PROCLAMATION DECLARING MAY 15-21, 2022 AS POLICE WEEK AND MAY 15, 2022 AS PEACE OFFICERS MEMORIAL DAY.

Sheriff Cutler stated there will be a memorial ceremony on May 10<sup>th</sup>. Commissioner Smith thanked the officers for their service and spoke about a family member who was killed in the line of duty. He also spoke about the 3 officers from Hays County who were lost in the last few years, including an officer from Dripping Springs. Judge Becerra suggested Commissioners Court goes into recess during the ceremony in May so the court members may attend. Commissioner Ingalsbe and Commissioner Shell thanked the officers for their service. A motion was made by Commissioner Smith, seconded by Commissioner Shell to adopt a Proclamation declaring May 15-21, 2022 as Police Week and May 15, 2022 as Peace Officers Memorial Day. All present voted "Aye." MOTION PASSED.

Sheriff Cutler praised the Hays County correctional officers for working hard while being short staffed. Captain Villalpando thanked the court and described the officers' around the clock work. Commissioner Shell stated that although the public does not see everything correctional officers do, they have a very challenging job. Judge Becerra praised the officers for staying on top of jail facility maintenance and thanked them for doing an emotionally challenging job. Commissioner Ingalsbe thanks the officers for their work. Commissioner Shell stated there have been more challenges since the pandemic and thanked the officers for their work. A motion was made by Commissioner Ingalsbe, seconded by Commissioner Shell to adopt a Proclamation declaring May 1-7, 2022 as National Correctional Officers and Employees Week. All present voted "Aye." MOTION PASSED.

# UPDATE BY DIRECTOR OF COUNTYWIDE OPERATIONS AND HAYS COUNTY STAFF ON THE EMERGENCY RENTAL ASSISTANCE PROGRAM (ERAP); POSSIBLE DISCUSSION AND/OR ACTION MAY FOLLOW.

Tammy Crumley, Countywide Operations Director, gave a report on the ERA Program. Disbursements are up about \$400,000 from the last meeting. The case count is about 400; 230 are pending citizen completion, 60 are under Auditor review, and about 100 are waiting for case manager review. The majority of applications are requests for additional assistance. Ardurra is working on program outreach in English and Spanish in the Kyle area. No action taken.

Jordan Powell, Assistant General Counsel, spoke about the new consolidated contract. This contract will keep current programs as well as add a new program for on-site blood draws and increased mental health services and staff. Judge Becerra asked for the dollar amounts for the previous contract compared to the new contract. Jordan stated the cost of the health services from May to October of this year will be \$258,673.17 per month for the jail and \$28,512.75 for the juvenile detention center. Starting October 1st, the jail rate will be \$276,064.42 and the juvenile detention center rate will remain the same. Vickie Dorsett, Assistant County Auditor, stated the cost for the jail contract is increasing by about 27% and the cost for the juvenile detention center contract is increasing by about 4%. Commissioner Ingalsbe and Commissioner Shell thanked Jordan and the Office of General Counsel for their work on the contract. A motion was made by Commissioner Ingalsbe, seconded by Commissioner Shell to authorize the County Judge to execute an Agreement for Adult and Juvenile Health Care Services with Wellpath, LLC pursuant to RFP 2021-P04 Medical Services for the Jail and Juvenile Detention Facilities and amend the budget accordingly. All present voted "Aye." MOTION PASSED.

# DISCUSSION RELATED TO THE HAYS COUNTY INMATE POPULATION, TO INCLUDE CURRENT POPULATION COUNTS AND COSTS.

Judge Becerra read the Sheriff's update of the inmate population. Current maximum jail capacity is 410 inmates. Jail Standards recommends holding 10% open, lowering current capacity to 368 inmates. The jail's daily average was 669, with a peak of 684 on April 22<sup>nd</sup>, 2022. The estimated cost for outsourcing inmates this week was \$113,457. The average number of outsourced males is 212 and females is 33. This week's inmates were housed in the following counties: Atascosa, Blanco, Comal, Fort Bend, Grimes, Lee, Maverick and Red River. The number of "paper-ready" inmates who are now wardens of the state is 57. Judge Becerra asked if the Sheriff's Office could report how many state inmates are moving through the system. Chief Davenport stated they can report how many state inmates are moved out of the county. Commissioner Shell stated Hays County is having to spend \$5-10 thousand per day on state inmates. No action taken.
