Commissioner Ingalsbe gave the invocation. Judge Becerra led the court in the Pledge of Allegiance to the United States and Texas flags. Judge Becerra called the meeting to order.

PUBLIC COMMENTS

Christopher Calkins made a public comment inviting the public and the court to the first annual People's Walk and spoke about Kyle AmVets Post 115's activities that support veterans. Laney Rhea made a public comment concerning county road quality and asked for better maintenance.

Wobus stated businesses can still sell fireworks, just not the restricted kind, and cities would determine their own displays. Kennedy recommended the motion be contingent on the Keetch-Byram Drought Index (KBDI) existing at 575 or greater prior to June 15th. Commissioner Shell amended the motion.

Judge Becerra stated the court is committed to the concerns raised and the item will be brought back in 2 weeks. No action taken.

37702 Executive Session pursuant to Sections 551.071 and 551.087 of the Texas Government Code: consultation with counsel and deliberation regarding economic development negotiations associated with Project Dark Monday, Project Fire Engine Red, Project Fresh Lime, Project Gold Fish and Project Thin Mint. Possible discussion and/or action may follow in open Court.

A motion was made by Commissioner Ingalsbe, seconded by Commissioner Jones to authorize the County Judge to execute a Chapter 381 Economic Development Incentives Agreement between Hays County and Yarrington Logistics Owner, LP, as discussed and presented in Executive Session.

Vote: 5 - 0 Passed - Unanimously

Commissioner Ingalsbe stated this economic development incentive agreement is not built around job creation; instead it is focused on opportunities created by the development of Shelf Space developing 5 spec buildings totaling approximately 1,392,000 square feet on approximately 97 acres of land. The proposal is to pay 75% of the value of ad valorem tax value real property taxes collected from 2022 through 2029.

A motion was made by Commissioner Shell, seconded by Commissioner Ingalsbe to authorize the County Judge to execute a Chapter 381 Economic Development Incentives Agreement between Hays County and Hill Country Group, LLC, as discussed and presented in Executive Session.

Vote: 5 - 0 Passed - Unanimously

Commissioner Shell stated this is for a film production company located at the La Cima Development. The City of San Marcos will be considering a 380 agreement, and this will provide opportunities for jobs and commercial development for the community. This will be one of the largest film production studios in the United States. The value added is estimated to be \$4 million in land development, almost \$170 million in vertical construction, and almost \$45 million in personal property. The incentives will begin in 2025 and run through 2029. Judge Becerra stated this project will help the county keep the tax rate low.

37703 Executive Session pursuant to Section 551.071 of the Texas Government Code: consultation with counsel regarding the outsourcing of inmates in the Hays County Corrections Facility, including interlocal agreements that facilitate outsourcing. Possible discussion and/or action may follow in Open Court.

Commissioner Shell spoke about the jail size and the need to outsource inmates to out-of-state facilities. Judge Becerra stated he is reluctant to do this and thanked the court for their work in solving this issue. He explained Hays County is not alone in jail overcrowding. Commissioner Shell stated this is in preparation for summer population increases and efficiency needs to be improved.

A motion was made by Commissioner Shell, seconded by Commissioner Jones to authorize the Office of General Counsel to include out-of-state jail facilities in its agreements with local governments for the outsourcing of inmates in the Hays County Jail Facility.

Vote: 5 - 0 Passed - Unanimously

Executive Session pursuant to Sections 551.071 and 551.074 of the Texas Government Code: consultation with counsel and deliberation regarding duties of all individual positions of the Hays County Transportation Department. Possible discussion and/or action may follow in open court.

No action taken.

37704 Executive Session pursuant to Sections 551.071 and 551.072 of the Texas Government Code: consultation with counsel and deliberation regarding the purchase, exchange, lease and/or value of Right of Way located at or near Shady Bluff Drive in Pct. 3. Possible discussion and/or action may follow in open court.

A motion was made by Commissioner Shell, seconded by Commissioner Smith to authorize the County Judge to execute Public Access Easements in relation to small parcels of Right of Way along Shady Bluff Drive in Precinct 3 of Hays County.

Clerk's Note: Resolution # 37705 was opened during Executive Session.

37705 Discussion and possible action related to the burn ban.

Mark Wobus, Fire Marshal, stated the Keetch-Byram Drought Index (KBDI) is now up to 546 and is raising about 10 points per day. He recommended the burn ban be implemented today. Mark Kennedy, General Counsel, stated an order reflecting the ban will be provided.

A motion was made by Judge Becerra, seconded by Commissioner Smith to implement a burn ban.

Vote: 5 - 0 Passed - Unanimously

Discussion related to the Hays County inmate population, to include current population counts and costs.

Judge Becerra read the Sheriff's update of the inmate population. Current maximum jail capacity is 410 inmates. Jail Standards recommends holding 10% open, lowering current capacity to 368 inmates. The jail's daily average was 684 inmates for the week of May 29, 2022, with a peak of 690 inmates on June 3, 2022. The estimated cost for outsourcing inmates this week was \$116,910. The average number of outsourced males is 215 and females is 37. This week's inmates were housed in the following counties: Atascosa, Blanco, Comal, Fort Bend, Grimes, Lee, Maverick and Red River. Judge Becerra emphasized that it is the Sheriff's responsibility to care for these inmates, not move them out of the jail, and asked that the next report includes the number of "Paper-Ready" Inmates. No action taken.
