THE FOLLOWING PROCEEDINGS WERE HAD, THAT IS:

Michael Pigg with Wayfinders Church gave the invocation. Judge Becerra led the court in the Pledge of Allegiance to the United States and Texas flags. Judge Becerra called the meeting to order.

PUBLIC COMMENTS

Laura Nunn made a public comment concerning the results of the 2020 election and electronic voting. Tamara Beck made a public comment concerning a proposed RV park development and possible water shortages that may result. Venus Wilder made a public comment concerning election integrity and the voting process. Dan Lyon made a public comment concerning expected population growth in the area and high taxes.

Presentation by the Homeless Coalition of Hays County on the 2022 Point-in-Time Report.

Reverend Joshua Sutherlun, Chair of the Homeless Coalition of Hays County, introduced Nancy Heintz, Coordinator of the Point-in-Time Count. Heintz presented the Point-in-Time Count for homelessness from January 27, 2022 and spoke about how the survey was conducted. Sutherlun provided specific numbers for those experiencing homelessness in Hays County, including first time and chronic homelessness, veterans, and children in shelters. He asked for representation in the Coalition from the County. Commissioner Ingalsbe thanked the presenters for bringing awareness to this issue. Commissioner Smith suggested coordinating with the Hays-Caldwell Women's Center, the School Districts, and veteran services. Heintz spoke about the unique situation of unsheltered students and the difficulties involved with chronic homelessness. Commissioner Smith spoke about including recipients of ERA funding in the count. Judge Becerra thanked the presenters for their work. No action taken.

Update by Staff from the Office of General Counsel on the Hays County Animal Control Ordinance.

Jordan Powell, Assistant General Counsel, said revisions are still being made to the Ordinance. Main focuses right now are legislative updates to animal control, best practices, and diverting cats from the shelter through Trap, Neuter, and Return. Judge Becerra asked about a potential timeline for the completed Ordinance. Powell said there are many players involved, and it could take a few more months. Judge Becerra explained that the County is creating a unified policy. Commissioner Smith spoke about the possible new animal facility and the need for consistent rules across the municipalities in the County. No action taken.

Chief Deputy Michael Varela, Constable Precinct 1, stated the department has one motorcycle being repaired, and they are hoping to add a second motorcycle officer to carry out all duties of the office. Commissioner Smith elaborated on the short life cycle of motorcycles and the inability to use older ones the County already possesses. Judge Becerra suggested selling old motorcycles instead of transferring them when they are no longer usable. Chief Deputy Varela explained the older motorcycles are used for training due to the rough handling involved. Judge Becerra and Chief Deputy Varela discussed justification for this purchase and the increased responsibilities of the Constable's Office. Commissioner Smith mentioned there is an outline of the Constable's duties in the budget presented at the previous meeting.

Robert Beck made a public comment concerning a possible increase in the volume of water and salt used due to the increased development. Sarah Davis made a public comment against the development of an RV park and the increase in water usage it would cause. Commissioner Shell clarified what the Commissioners are allowed to comment on during Court meetings and that they are unable to deny permits for development based on proposed use of the property. The County's issuance of permits are based on wastewater, floodplains, and fire codes, not groundwater use. The County does require water availability studies to be completed. He stated a long-term goal would be for unincorporated areas to be able to determine their own development restrictions. Elaine Cardenas, County Clerk, clarified the RV park development is not on this week's agenda. Cardenas read an emailed public comment from Mark Key that stated this item conflicts with a Resolution passed by the Court in 2021. Commissioner Shell explained why the item does not conflict with the Resolution. Marcus Pacheco, Director of Development Services, provided background on the item and stated the subdivision meets all County regulations. The County is awaiting the water availability study. Commissioner Shell amended his motion to be conditional upon a water availability study. Commissioner Smith said he prefers projects with larger lot sizes like this development to avoid high density. He has asked the South Texas County Judges and Commissioners Association to consider legislative priority for more zoning authority. Pacheco explained the water availability study, and the court discussed action that can be taken once they have the results. Commissioner Ingalsbe thanked those who made public comments and emphasized that this item is not for an RV park. Commissioner Shell stated if the RV park is not a formal subdivision it will likely not be on a court agenda, unless the developers are requesting any variances. Permits are granted administratively through Development Services.

A motion was made by Commissioner Shell, seconded by Commissioner Smith to approve the preliminary plan of 272 AC Fitzhugh (37 lots), conditional upon a water availability study.

Discussion and possible action to approve a Resolution to requesting that the LCRA work with local leaders and stakeholders to accelerate the update of its Water Management Plan to implement a more protective approach to managing the Highland Lakes.

Jo Karr Tedder, President of Central Texas Water Coalition, made a public comment regarding the Resolution and the need for water management. Commissioner Ingalsbe stated she has been made aware of concerns about the Resolution and would like more time to look into it. The court discussed with Tedder the progress this Resolution has made in surrounding counties. Commissioner Shell spoke about the complicated nature of this situation and said the LCRA has begun communicating with local jurisdictions about the current water management plan. Commissioner Smith spoke about the need for more water and his hesitancy in receiving it from Lake Travis. He expressed concerns over the Resolution and his willingness to work with Tedder and the State Legislature on this issue. Tedder spoke about the urgency of the issue and the need for regional collaboration. Judge Becerra expressed support for this issue. Commissioner Ingalsbe suggested changing the wording of the Resolution. Commissioner Jones noted the LCRA's current plan is to take action by 2025. Commissioner Smith said the LCRA is already working on their 2026 plan and spoke about his involvement in their meetings, inviting the court to join him. A motion was made by Judge Becerra to approve the Resolution. Motion failed due to lack of second. No action taken.

Judge Becerra opened the Budget Workshop at 11:39 a.m. Vickie Dorsett, Hays County Budget Office, provided the court with a schedule for the workshop. She stated elected official salaries must be published by September 1. Shari Miller, Director of Human Resources, updated the court on the progress of the employee salary study and suggested working on the elected official salaries internally. The court discussed the need for results from the salary study. Dorsett stated several departments have requested incentive pay for bilingual employees. Commissioner Smith asked for a verification process for those receiving incentive pay. Dorsett stated there will be computer hardware price increases, and provided a schedule for the next meeting's budget workshop. Judge Becerra closed the Budget Workshop at 11:49 p.m. No action taken.

Discussion and possible action related to the burn ban.

Mark Wobus, Fire Marshal, stated the burn ban is still in effect. He updated the court on various fires around the County. The court thanked first responders for their efforts to contain the fires, as well as individuals and businesses in the community for providing resources and food to volunteers. Wobus mentioned possible rain chances that are being monitored. No action taken.

Discussion related to the Hays County inmate population, to include current population counts and costs.

Judge Becerra read the Sheriff's update of the inmate population. Current maximum jail capacity is 410 inmates. Jail Standards recommends holding 10% open, lowering current capacity to 368 inmates. The jail's daily average was 657 for the week of July 31, 2022 with a peak of 661 inmates on July 31, 2022. The estimated cost for outsourcing inmates this week was \$98,480. The average number of outsourced males is 165 and females is 39. This week's inmates were housed in the following counties: Atascosa, Blanco, Burnet, Comal, Fort Bend, Lee, Maverick, and Red River. The number of "paper-ready" inmates who are now wardens of the state is 25. No action taken.
