Chris Millar, Lead Pastor at The Well Community Church, gave the invocation. Judge Becerra led the court in the Pledge of Allegiance to the United States and Texas flags. Judge Becerra called the meeting to order.

David Lemke made a public comment asking for assurance of election integrity. Dan Lyon made a public comment concerning County debt and spending. Amy Kamp made a public comment concerning complaints about medical services provided by the Hays County Jail.

Update by Charlie Campise on the Hill Country Mental Health Development Disabilities Board Meeting.

Charlie Campise, Secretary of Hill Country Mental Health and Development Disabilities Center, provided an update from the agency's last meeting. Topics included the next year's strategic plan, staff shortages, and the response to the Uvalde school shooting. Judge Becerra opened the public hearing at 1:09 p.m. Michele Donnelly spoke about the increased workload for PALS and requested additional funding. Vickie Dorsett, Hays County Budget Office, reviewed additional budget requests for the General Fund including Justice of the Peace Precinct 4 salary increase of \$9,172 which was approved August 9th, Juvenile Probation Department printing budget inadvertently left out of the budget in the amount of \$750, DPS License and Weight station water cooler for \$675 annually, Haskell County jail contract in the amount of \$3,467,000, 2 Wimberley SRO positions, 3 Constable positions with equipment in the amount of \$14,033, Central Texas Dispute Resolution Center for \$50,000, equipment purchases and vehicle lease assignments. The total impact to the General Fund would be \$208,178. The court discussed budgeting for additional projects. The court agreed to earmark 2.5 Million dollars per year, for the next 2 years, from reserve funds to help implement the Mental Health facility assessment currently under way to assist with the Mental Health effort.

A motion was made by Commissioner Shell, seconded by Judge Becerra to approve the recommendations for the General Fund as discussed in court, with \$7,623 going into contingencies.

The court discussed elected official salaries. Commissioner Shell suggested no increases for elected official salaries or allowances and putting the allocated 6% into the employee pool, with the Court agreeing.

Clerk's Note: Judge Becerra called for a recess that began at 1:47 p.m. and resumed back into open court at 2:07 p.m.

A motion was made by Commissioner Smith, seconded by Commissioner Shell to set the Fiscal Year 2023 salaries and allowances for Elected Officials as discussed with no increases and to accept the changes for the Fiscal Year 2023 Proposed Budget as presented by the County Budget Office; set a Final Public Hearing to adopt the Fiscal Year 2023 Budget and levy the taxes to be held on September 20, 2022, at 1:00 p.m. in the Hays County Commissioner Courtroom located at 111 E. San Antonio St., San Marcos, Texas.

Commissioner Smith emphasized that the tax rate is lower than the rate adopted in 1988. Judge Becerra clarified that the Central Appraisal District works independently of the Court. Judge Becerra closed the public hearing at 2:16 p.m.

12:00 p.m. - Budget Workshop regarding the FY 2023 Hays County Budget. Possible action may follow.

Judge Becerra opened the Budget Workshop at 12:00 p.m. Britney Richey, Hays County Treasurer, presented the Retiree Committee Recommendations. She recommended no changes this year, and an indexing study through TCDRS for possible increases next year. Shari Miller, Director of Human Resources, presented a recommended 6% salary increase for elected officials. Commissioner Shell spoke about the history of elected official salary increases and options moving forward. The Court discussed whether to increase elected official salaries based on similar county averages, job responsibilities, and previous action taken by the Court. Vickie Dorsett, Hays County Budget Office, reviewed budget requests made. The court agreed to include the following in the budget: \$10,000 for Central for the Indigenous and Tejano Community (CITC), \$10,000 for Greater San Marcos Area Seniors (a \$6,000 increase), \$40,000 from reserves for 4 HVAC units, \$50,000 from reserves for the Central Texas Dispute Resolution Center, \$10,000 for PALS, and an additional \$5,000 for Capital Idea. The court discussed the County Clerk's request for 2 new positions and cubicles. Commissioner Smith proposed setting aside \$500,000 for an online constituent portal. Judge Becerra closed the Budget Workshop at 1:09 p.m. No action taken.

Clerk's Note: Executive Session began at 10:48 a.m. and resumed back into open court at 11:59 a.m.

Discussion and possible action related to the burn ban.

Mark Wobus, Hays County Fire Marshal, updated the court on drought conditions and recent rainfall totals, and recommended the burn ban remain in effect. Judge Becerra spoke about the dangers of low water crossings. Mark Kennedy, General Counsel, stated the burn ban will expire in September and action will need to be taken at the next meeting if the court wishes to extend it. No action taken.

Discussion related to the Hays County inmate population, to include current population counts and costs.

Judge Becerra read the Sheriff's update of the inmate population. Current maximum jail capacity is 410 inmates. Jail Standards recommends holding 10% open, lowering current capacity to 368 inmates. The jail's daily average was 647 with a peak of 653 inmates on August 14, 2022. The estimated cost for outsourcing inmates this week was \$79,739. The average number of outsourced males is 134 and females is 30. This week's inmates were housed in the following counties: Atascosa, Blanco, Burnet, Comal, Fort Bend, Lee, Maverick, and Red River. The number of "paper-ready" inmates who are now wardens of the state is 17. No action taken.
