Judge Becerra opened the public hearing at 1:00 p.m. Ellen Ermis spoke on new members, and is pleased to accept donations of 1\$2,000 and for additional allocation to the group. Domingo Castilleja spoke in support and asked for court to reconsider application for \$20,000. Mary Helen Tijerina gave her testimonial of the program and expressed her support for Capital Idea. Reverend and Dr. Todd Salmi, President of Southside Community Center, spoke on the services offered to the community. He stated the help they can provide is crucial and asked they increase their allocation by \$15,000. Kathy Morris, Chair of Hays County Family Justice Center, made a public comment thanking many offices for their partnership. She requested \$45,000 for the share of the City/County partnership and \$10,000 for operation. Vickie Dorsett, County Budget Officer, spoke on the budget changes listed in her handout, including an additional \$8,000 for Kyle Area Senior Zone and \$15,000 for Southside Community Center. She stated there was an additional \$7,623 that was in savings that was added to contingencies. There was also an additional \$10,845 that can be added to the budget due to pricing differences. As a result of the Grievance hearing, \$17,750 for increases in Justice of the Peace travel allowances. The Extension office would like to convert a position at the cost of \$2,480. Constable Precinct 1 requested to convert 4 positions, which if approved, the CBA plan could absorb the cost to move them into that new plan. Judge Becerra proposed moving poll worker salary to \$20 per hour. Dorsett stated the Elections Administrator sets those pay rates. This would not be a budget impact but may have to come back to court for approval. Information Technology department is requesting \$5,000 Continuing Education funds. Sheriff's Office has requested to add the Corrections Specialist position to the list of positions that are approved for overtime payments. Kyle Housing Authority has requested a one-time capital contribution of \$75,000 for repairs to the Pete Dressen Housing Apartments which have not passed the HUD inspections, to match the City of Kyle's contributions. Grant Revenue changes as listed, totaling \$16,971 for the General Fund and \$9,539,341 for the ARPA Fund. Additionally, item K1 from today will need to add \$10,800,000 to the LPPF fund revenue for the total assessment, a total of 6%. Computer related changes recommended by Information Technology Department. FY 22 Capital that will not be received by end of fiscal year to roll over to FY23. Minor changes to DA Drug Forfeiture fund of \$9,840 to budget for Miscellaneous expenses. County Clerk's office is requesting 2 high performance scanners totaling \$31,500 utilizing the Records Management fund. Also, County Clerk has requested the court establish the second DC III position that funds were set aside for in the August meeting. Dorsett stated we will need to budget the fund balance in the Park bond fund for agreement with City of San Marcos for Five Mile Dam. This will consist of 800,000 square feet of new spec building located on the land. Grant payment shall be in amount equal to 50% of the real property taxes paid by developer. Grant payment, otherwise owed by the County for the year, during which such leasing occurred, will be reduced in proportion to the square footage of the area lease relative to the total square footage of the building improvements. The jail's daily average was 650, with a peak of 663 on September 16th, 2022. The estimated cost for outsourcing inmates this week was \$129,024. The average number of outsourced males is 205 and females is 24. This week's inmates were housed in the following counties: Atascosa, Blanco, Burnett Comal, Fort Bend, Haskell, Lee, Maverick and Red River. The hopes is Maverick and Red River will soon be zeroed out. The number of "paper-ready" inmates who are now wardens of the state is 31. No action taken.
