IAW county policy and in conjunction with the auditors' office, quotations were requested from multiple firms including Swagit, Fidlar, Tyler and GovOS.

Swagit declined to bid as they do not currently have the capability and do not plan to invest in this service at this time.

Fidlar submitted a quote for \$25K one-time charge plus \$9,770 for Tears 1 and 2 and \$10,385 for Year 3. They have not been certified in Texas, and they have not submitted an application for certification as a partner to any county clerk's office in Texas.

Tyler submitted a quote for \$4,200, but it was for only one small part of the Remote Marriage License process only capturing online signature. Tyler has stated they are working on developing the capability but do not yet have it. They must develop the program and then obtain certification. It is unlikely they will have a fully developed program before 2 years from now.

GovOS submitted a quotation for \$12,000 per year for 3 Years. They will also charge applicants and \$10 convenience fee. The Texas Office of Administration has certified GovOS and has said that GovOS is currently the only company that has been certified or that has applied for certification. RML services has the potential to increase revenue as applicants can submit from other states and countries.
